OFFICE ORDER

Reg: Revised Guidelines -2022 for Issue of Blood / Blood Components to Govt. and Non Govt. Blood Centers.

In light of the recommendation of the Directorate General of Health Services, Ministry of Health & Family Welfare GOI, as conveyed by the Additional Director DGHS, GOI, vide its F.No. IM11012/07/2022/NBTC dated. 14th June 2022 about the Revised Guidelines-2022 of processing charges for Blood and Blood components, the State Blood Transfusion Council, Govt of NCT Delhi, has decided to allow revision of the processing charges with immediate effect for issue of Blood and Blood components by the Government and Non Government Blood Centers, with upper limit of charges as given hereunder:

2.1 PROCESSING CHARGES FOR GOVT. BLOOD CENTERS

| S.No | Blood / Components | Processing Charges (In Rupees) |
|------|----------------------|--------------------------------|
| 1. | Whole Blood | Rs. 1100/- |
| 2. | Packed Red Cells | Rs. 1100/- |
| 3. | Fresh Frozen Plasma | Rs. 300/- |
| 4. | Platelet concentrate | Rs. 300/- |
| 5. | Cryoprecipitate | Rs. 200/- |

2.2 PROCESSING CHARGES FOR NON- GOVERNMENT BLOOD CENTERS

| S.No | Blood / Components | Processing Charges (In Rupees) |
|------|----------------------|--------------------------------|
| 1. | Whole Blood | Rs. 1550/- |
| 2. | Packed Red Cells | Rs. 1550/- |
| 3. | Fresh Frozen Plasma | Rs. 400/- |
| 4. | Platelet concentrate | Rs. 400/- |
| 5. | Cryoprecipitate | Rs. 250/- |



- 3.1 It would continue to remain mandatory for all Blood Centers (Government supported and non- Government supported) to provide Blood / Blood component free of cost to the following patients, who require repeated blood transfusion as life saving measure:-
- Thalassemia
- Hemophilia
- Sickle Cell Anaemia
- Any other blood dyscrasia requiring repeated blood transfusion
- 3.2 Processing charges for blood and blood products for below poverty line (BPL) patients accessing blood from non- Government supported blood centers shall be in compliance with the charges as revised by the SBTC GNCT, Delhi.
- 3.3 The order will come into force with immediate effect.
